3.2 Consider and Act upon approving variance request for Justin Matous at 331 East Bonham St in Tom Bean.

Discuss:

Justin Matous requested variance to place a 16' x 20' Storage building in back yard. Available space 32' x 70'. Based on pictures provided, there are two buildings on east Side of fence and house. The small storage shed on North East side of existing fence is covered in motion for variance and to be moved inside fence. The other structure against the house, a chicken coup, was not presented in the

Motion:

Upon motion by Tworek and seconded by Jones the board voted Four (4) for and Zero (0) opposed to approve a 5' variance from fence on North side to proposed placement of storage shed; on the East side removal of existing fence for proposed storage shed placement, no variance is necessary. The area between house and proposed placement of storage building is 9', therefore a 6' variance between house and storage shed proposed placement; with the recommendation that the storage building be built, painted or stained to match the fence. The storage shed currently on Northeast corner outside of fence is to be moved inside fence with a variance of 5' from fence on two sides. Motion passed
